COUNT ONE

**MURDER
FIRST DEGREE**

The Grand Jurors of the State of New Jersey, for the County of Ocean, upon their oaths present that **AZRIEL RASHAD BRIDGE**, on or about June 9, 2004, in the Township of Dover, County of Ocean, and within the jurisdiction of this Court, purposely or knowingly did cause the death of Shirley Reuter, contrary to the provisions of N.J.S.A. 2C:11-3a(1) or (2) and against the peace of this State, the Government and dignity of the same.

COUNT TWO

**FELONY MURDER
FIRST DEGREE**

The Grand Jurors of the State of New Jersey, for the County of Ocean, upon their oaths present that **AZRIEL RASHAD BRIDGE**, on or about June 9, 2004, in the Township of Dover, County of Ocean, aforesaid, and within the jurisdiction of this Court, acting alone or with one or more persons, did cause the death of Shirley Reuter, during the commission of the crime of robbery, contrary to the provisions of N.J.S.A. 2C:11-3a(3) and against the peace of this State, the Government and dignity of the same.

COUNT THREE
ROBBERY
FIRST DEGREE

The Grand Jurors of the State of New Jersey, for the County of Ocean, upon their oaths present that **AZRIEL RASHAD BRIDGE**, on or about June 9, 2004, in the Township of Dover, County of Ocean, and within the jurisdiction of this Court, in the course of committing a theft, knowingly did inflict bodily injury upon Shirley Reuter, by use of deadly weapons, contrary to the provisions of **N.J.S.A. 2C:15-1** and against the peace of this State, the Government and dignity of the same.

COUNT FOUR

POSSESSION OF A WEAPON FOR AN UNLAWFUL PURPOSE
THIRD DEGREE

The Grand Jurors of the State of New Jersey, for the County of Ocean, upon their oaths present that **AZRIEL RASHAD BRIDGE**, on or about June 9, 2004, in the Township of Dover, County of Ocean, and within the jurisdiction of this Court, did possess a certain weapon, that is an iron rod with the purpose to use it unlawfully against a person, or property of another, contrary to the provisions of **N.J.S.A. 2C:39-4(d)** and against the peace of this State, the Government and dignity of the same.

COUNT FIVE

POSSESSION OF A WEAPON FOR AN UNLAWFUL PURPOSE
THIRD DEGREE

The Grand Jurors of the State of New Jersey, for the County of Ocean, upon their oaths present that **AZRIEL RASHAD BRIDGE**, on or about June 9, 2004, in the Township of Dover, County of Ocean, and within the jurisdiction of this Court, did possess a certain weapon, that is a knife with the purpose to use it unlawfully against a person, or property of another, contrary to the provisions of **N.J.S.A. 2C:39-4(d)** and against the peace of this State, the Government and dignity of the same.
